America's Auto Auction Lancaster follows NAAA

NAAA Policy Effective: April 3rd, 2023 with the following Exceptions

- ➔ **NO RETAIL CUSTOMERS** - Any dealer that is found with a retail customer may have their auction privileges revoked.
- ➔ **This auction is for licensed and registered dealers only.**
- ➔ The licensed and registered dealer will be held responsible for all business transactions under his company name at America's Auto Auction Lancaster. All changes of ownership, authorized representatives, banking facilities, addresses and telephone numbers must be reported to America's Auto Auction Lancaster.
- ➔ Personal checks and drafts are not accepted.
- ➔ No vehicle is authorized to leave the auction grounds unless it is accompanied by a validated gate pass. All vehicles are subject to inspection.
- ➔ Vehicles being returned to the Auction must be returned in the same or better condition than when purchased. No vehicles may be returned with excessive mileage. Mileage is limited to a maximum of 200 miles. If distance to and from Auction to Buyer's dealership is greater, an exception may be made by Auction Manager.
- ➔ No vehicles may be sold without a negotiable title (For Example: "Bill Of Sale Only").
- ➔ America's Auto Auction Lancaster will not allow the transfer and sale of any vehicle on "repo papers".
- ➔ All "**IF**" sales are binding on the buyer for **90 minutes** from the time of sale.
- ➔ Titles must be presented at the counter by close of business on sale day if an announcement of "T/A" was not made at the time of sale, and sold under the Blue Light.
- ➔ After 21 days: for vehicles sold T/A the seller has until the close of business on the next day, to produce a valid/negotiable title, from the time the Buyer notifies the Auction of their intent to return a vehicle for no title.
- ➔ Buyers are cautioned not to sell or spend money on T/A (Title Absent) vehicles until the title is received. Neither the auction nor the seller will be held responsible for repairs on T/A purchases. Seller will be responsible for transportation charges to return a sold vehicle when a negotiable title is not presented to AAALancaster, Inc. within the 21 calendar day T/A policy.
- ➔ Buyers may be assessed a fee for excessive mileage (distance to and from dealership) at a rate of **50¢/mile** for vehicles sold title absent and returned for no title. **Fee will be paid to selling dealer.**
- ➔ A service fee of \$100 will be charged on all returned checks.
- ➔ Titles with the following defects will not be accepted: alterations and/or erasures, incorrect VIN, improper reassignments, and missing signatures.
- ➔ Because ownership of the vehicle or its accessories is never transferred to Americas Auto Auction Lancaster, the **Auction does not assume liability for any theft or damage.** The titled owner of the stolen or damaged property must make claim to his/her insurance company. Any vehicle and/or personal property left on the premises is done so at the owner's own risk.
- ➔ Any vehicle titles with a brand, status or any other indication of Exempt from odometer disclosure **MUST** be announced. The seller may represent miles on exempt vehicles as being actual; any disclosures made by the seller and all known odometer discrepancies are grounds for arbitration.

PSI POLICIES

- ➔ **PSI Fee is \$190** and good for 10 calendar days (sale day is day 1).
- ➔ No exceptions past day 10.
- ➔ **The buyer will be charged for inspection regardless of a “Pass” or “Fail” resolution, due to services provided as requested.**
- ➔ The purchase of a **Post Sale Inspection** is a guarantee solely to the “Buyer”. The primary responsibility for undisclosed defects will lie with the “Seller” and consistent with the NAAA Policy. The Auction provides coverage beyond the timeframes outlined by the NAAA, but within the 10 day guarantee.
- ➔ The Auction reserves right to extend **arbitration** periods, for vehicles that went through the **PSI** process beyond the day of the sale, for motor **and/or** driveline performance issues that occur under “**cold**” conditions.
- ➔ The Auction reserves the right to extend resolutions of Arbitrations and PSIs beyond the day of the sale and deemed necessary by Management.
- ➔ If a price adjustment is made regarding issues resolved through **PSI** or Arbitration, and accepted, the vehicle becomes the “**AS-IS no arbitration**” property of the buyer. This is regardless of additional defects found.
- ➔ The auction reserves the right to repair vehicles covered by a **PSI** guarantee, repairs under \$800 will be responsibility of the buyer.
- ➔ The Auction may request a **PSI** claim to be inspected at the closest America’s Auction or manufacture’s shop based on circumstances **and/or** location of vehicle as deemed by management
- ➔ Only Cars and Light Duty Trucks are eligible for PSI
- ➔ All Diesel Powered Vehicles 5 years **and** older from current year are not eligible for **10 Day PSI**, however can be arbitrated up until 5pm day of sale.
- ➔ Vehicles 15 calendar years and older **and/or** over 125,000 miles will **NOT** be eligible for **10 Day PSI**. *These vehicles are only eligible for sale day arbitration before 5pm.*
- ➔ Following Must be sold **AS-IS** & not subject to Arbitration or **PSI** excluding Title Discrepancies:

Towtrucks, RV’s, motorcycles, ATV’s, boat’s, trailer’s, offroad vehicles, and equipment.

SELLING LIGHT SYSTEM:

Vehicles **Not Eligible** for **10 Day PSI**,
but can be arbitrated up until 5pm day of sale.

*Alfa Romeo, Aston Martin, Audi A8, R8, S8, Bentley, BMW i8, Bugatti, Dodge Viper, DMC 12, Ford F-450, Ford GT, Ferrari, Fisker (electric car), H1 Hummer, Jaguar, Laforza, Lamborghini, Land Rover, Lexus FF Sport, Lexus IS-F, Lexus LFA, Lotus, Maserati, Maybach, McClaren, Mercedes-Benz SLR, Mitsubishi Lancer Evo, Nissan GTR, Panoz, Porsche, Rolls Royce, Subaru WRX, Tesla, and **All Electric Vehicles***

Also High Performance, Low Production, Modified or Significantly Altered,
are **Not Eligible for PSI**.

Please contact Auction prior to Purchase to Check PSI Eligibility

For arbitration of vehicles selling at America's Auto Auction Lancaster for \$75,000 or more, the item in question for arbitration must have a minimum repair cost of 2% of the purchase price to qualify.

As vehicles are being offered for sale, a Green, Yellow, Red or Blue light will signify the following:

ARBITRATION / STRUCTURAL DAMAGES:

Local Auction Arbitration: Rules & Exceptions

- ➔ Payment for Vehicle Purchases is due on Sale Day.
- ➔ ALL Vehicles that **Sell Under \$3,000** will automatically be sold **AS-IS** & can only be arbitrated for Title Discrepancy and Odometer Discrepancy, and cannot be arbitrated for frame damage. Seller has right & opportunity to sell any vehicle \$3,000 and over either As-Is or with a Green Light by their choice.
- ➔ Vehicles with Check Engine light on in vehicle must be announced with specific issues as to why the Check Engine Light is actually on. If Seller doesn't announce Specific Reasons for Check Engine Light being on vehicle can be arbitrated if repair is greater than \$800.
- ➔ Any timing chain defects are subject to arbitration regardless of the cost to repair
- ➔ Any Catalyst Efficiency defect is subject to arbitration regardless of the cost to repair
- ➔ A No Sale Fee of \$50.00 will be charged to vehicles running for the fourth (4th) week and every week thereafter that the vehicle is registered.

Structural Damage:

- ➔ Any existing permanent (kinked or broken) structural damage. Previous policy required disclosure of a vertical deflection, to the floor/trunk panels, greater than 2 inches. The "2 inch" rule has been dropped and any damage deemed permanent must be disclosed.
- ➔ Structural damage due to corrosion. If the material has been reduced by 25% or more must be disclosed.

Test Drive Policy:

- ➔ All vehicles must be test driven, on the DAY of the SALE, and returned to arbitration within one (1) hour for any undisclosed defects. All Arbitration matters must be processed through the main office. Dropping a vehicle at the canopy does not constitute the registration of a complaint.
