



This location follows the NAAA Arbitration Policy and America's Auto Auction Terms and Conditions. However, **certain amendments, exceptions, or operational differences** may apply. The details below outline our specific local policies.

Arbitration requests must be submitted via the Auction VCommerce App only.

All vehicles sold "**RED LIGHT/AS IS**" cannot be arbitrated for Structural damage or alteration regardless of sale price.

Green light vehicles that run at America's Auto Auction Erie manufactured within 10 years from current model year and with a sale price greater than \$2999 and less than \$75,000 with an odometer reading of less than 150,000 miles are eligible for a Full Post Sale Inspection. 125K–149,999 miles a \$50+ high-mileage premium will be added to the PSI fee charged to the buyer. Vehicles, which pass PSI, will carry a 7-Day Auction Guarantee. Vehicles, which fail enter arbitration becoming an 'AS IS' sale if purchased.

Vehicles sold Green Light by the Seller, which do not meet these requirements, are eligible for a Sale Day Check. A guarantee will not be provided by America's Auto Auction Erie. The presence of a green light does not entitle the purchaser to a PSI carrying a 7-day auction guarantee.

Vehicles that run at America's Auto Auction Erie with an announced Powertrain Guarantee are eligible for a mechanical check.

Vehicles sold off the block are not subject to Arbitration and are not eligible for a Post Sale Inspection without authorization from the selling dealer.

Buyer is responsible to communicate need for a Post Sale Inspection, within two hours from time of purchase of a qualifying vehicle, as indicated on the block ticket.

PSI Terms and Conditions The Buyer is responsible for the PSI fee; Pass or Fail Guarantees and provisions apply to original Buyer only and are non-transferable to a subsequent wholesale or retail buyer Qualifying PSI guarantees are for 7 days, day of sale being day 1

An inspected item which fails within the guarantee period and costs more than \$800 will be repaired or replaced at the seller's discretion America's Auto Auction Erie determines repair costs using aftermarket, remanufactured and used parts with labor rate of \$80/hour, per NAAA policy Vehicles challenged for issues must have 200 or less accumulated miles from time of PSI to challenge Vehicles returned must be in same or better shape as when purchased Vehicle returns and any fees/tow charges are the responsibility of the Buyer All returns must be made to the America's Auto Auction Erie within 48 hours of the 7 day period expiring (Noon Wednesday-Noon Friday)

1. **PSI Checklist:** Odometer verification Engine Function and Operation (lower engine only)* Transmission Engages and Functions. CVT transmissions (no arbitration), 4x4 System Engagement Emissions Control Equipment Present* Front and Rear Differential (except Jeep) ABS/Brakes Function (if ABS light is on)* Electrical Accessories checked for function (current model year only)* Air Conditioning System (current model year only)* Air Bag/Supplemental Restraint System* Frame or Unibody Structure checked for damage (visual check only)* Bed Floors checked for damage (visual check only)* Hybrid components are not covered under a 7-Day, only the gasoline powered systems

Announced structural Alteration/Damage/Mechanical defect is eligible for PSI; is not a condition for failure; will not be protected under PSI Guarantee *Not included in Mechanical/Powertrain Check
